You are invited to participate in the Beyond Benefits Study, a national study paid for by the Social Security Administration (SSA). The study will collect information about the service, medical and employment needs of working-age adults who get disability payments now or stopped receiving disability payments due to medical improvement. By participating in this study, you will help SSA understand the policies and programs that may help people who stop receiving disability payments.

SSA hired Westat, a national research company, to conduct the study. Westat is inviting you to participate in a series of six (6) 1 hour meetings with a motivational interviewing counselor. In each meeting, you and the interviewer will talk about your goals and dreams, and brainstorm with you about ways of thinking about work and careers. The goal of the meetings is to help you think through your feelings about looking for work or advancing your career and support you in pursuing the goals you set. The meetings will be virtual (video conference using Microsoft Teams) or by phone over a period of three to six months. Once you have completed the first meeting, we will mail you a \$40 Visa gift card. We will mail you a \$25 Visa gift card after you complete each subsequent meeting; **up to a total of \$165 in Visa gift cards** if you complete all six meetings. You can stop each meeting at any time without penalty. You can choose not to answer one or more of the questions.

Participation in this study is voluntary. Participation in this study will not affect your eligibility for benefits now or in the future. SSA and Westat will protect all information that could identify you. As described in the Study Consent, that you will review before you participate, we will safeguard the information you provide and will use it for limited purposes, consistent with applicable Federal law, regulations, and directives. Your name or other identifying information will not be included in any published reports.

BEYOND BENEFITS STUDY SOCIAL SECURITY ADMINISTRATION Consent to Participate in Motivational Interviews

What is the purpose of the study?

The Social Security Administration (SSA) is conducting the Beyond Benefits Study to collect information about the service, medical and employment needs of working-age adults who currently receive disability-related payments or stopped receiving disability-related payments from SSA due to medical improvement. SSA hired Westat, a national research company, to carry out the study. The purpose of the research is to help SSA identify ways to help people who may be leaving or have left disability benefit programs.

What we are asking of you?

We seek your consent for your voluntary participation in six (6) 1-hour meetings with a motivational interviewing counselor via Microsoft Teams videoconference¹ or telephone over a period of three to six months. We will ask for your permission to send text message reminders about the study. Depending on your texting plan, you may incur a charge for these texts. If you agree, you will be able to opt-out of receiving these reminders at any time by replying "STOP" to the text or by calling the Help Desk at Westat.² During the meetings, the interviewer will talk to you about your goals and dreams, and brainstorm with you about ways of thinking about work and careers. The purpose of each session is to help you think about how you feel about looking for work or advancing your career and support you in pursuing the goals you set. The interviewer will ask questions about your willingness to get a job or your interest in advancing your career; your employment goals; and what employment activities you would like to do or have done.

We ask for your permission to record each interview so we accurately capture what you tell us. If at any point you do not wish to be audio-recorded, the interviewer will stop the audio-recording and end your interview session. The recording will be used to develop the report and will be destroyed at the conclusion of the study The reports will not contain information that could identify you. If you decide <u>not</u> to volunteer, it will not affect any decision SSA makes about your current, or future, disability benefits or payments.

What benefits will you get for participating?

You may receive support to pursue your goals related to employment. You will contribute to SSA's understanding and improvement of policies and programs that may be helpful to people who leave disability programs when their condition medically improves. After completing the first interview meeting, we will mail you a \$40 Visa gift card. You will receive a \$25 Visa gift card for each subsequent completed meeting; **up to** \$165 in Visa gift cards if you complete all six meetings.

Persons eligible for participation in the study.

You were randomly selected to participate in the study from a list of current and former Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI) program beneficiaries. Everyone on the list had the same chance of being selected.

What is the study doing to minimize your risks?

There is a small risk of disclosure of your personal information. To reduce this risk, we will separate any information that identifies you from the rest of your data and store those identifiers separately. Although it is not likely, it is possible that some of the questions may make you feel anxious or frustrated. If this happens, you can skip the questions or stop participating. If you get upset, you may request a referral to crisis management services. It is your decision to use this referral.

How will we protect your privacy?

We will follow Federal law and regulations to protect your privacy. SSA and Westat will protect your personal information collected during the study. The information we collect is used for research in limited ways, consistent with applicable Federal law, regulations, and directives. For example, we use your thoughts and comments about employment, combined with thoughts and comments about employment from other people interviewed, to understand experiences associated with finding employment. Your name or other identifying information will not be included in any published reports.

Privacy Act Statement Collection and Use of Personal Information. Section 1110(a) of the Social Security Act, as amended, allows us to collect this information, which we will use to help the Social Security Administration (SSA) identify ways to help people who may be leaving or have left disability programs. Providing us this information is voluntary; not providing all or part of the information will not affect your SSA benefit. As law permits, we may use and share the information you submit, including with other Federal agencies, contractors, student volunteers, and others, as outlined in the routine uses within System of Records Notice (SORN) 60-0218, available at www.ssa.gov/privacy. The information you submit may also be used in computer matching programs to establish or verify eligibility for Federal benefit programs and to recoup debts under these programs.
