## Personal and Psychosocial Development Assessment

The objective of this section is to assess the personal growth and psychosocial development of individuals enrolled in RAPP, as they are relevant to RAPP activities. Grantees are to assess RAPP participants at the time of enrollment, and at the end of each fiscal year of the project period based on the following scale:

1. **Not at all** - Client cannot complete activities in this area without assistance from the grantee.
2. **Sometimes** - Clients can complete some activities on their own, but still require assistance from the grantee for related tasks.
3. **Most Of The Time** - Clients are able to complete most tasks in this area on their own, but may request occasional assistance from the grantee.
4. **All The Time** - Clients are able to complete all activities in this area without any assistance from the grantee.

Assessments are to be represented by the mean score of all participants. For the purpose of this section, mean scores will be calculated as:
