

# Focus Group Interview Protocol – States, Tribes, Local, and Territorial Entities and Providers

## I. INSTRUCTIONS FOR INTERVIEWERS

Tailor the following interview guide by (1) skipping sections or questions not relevant for the respondent (e.g., federal program staff do not need the PRA Statement); or (2) modifying questions to reflect their role, their professional perspective/knowledge, or information obtained before the interview. Use the follow-up questions or probes (dashed items below the numbered questions) as needed to obtain additional information or clarification. If you are running out of time, prioritize the most important questions.

You should be familiar with the respondent's role and office, so you should select and/or tailor questions, as relevant, to probe for the respondent's insight into the key research questions.

Before you begin the interview, read the script to describe the purpose to respondents, answer any questions they have about the session, and ask for their consent to record the interview.

### A. Purpose

The purpose of this learning session is to identify areas of improvement and support for the state, tribal, local, and territorial (STLT) human services jurisdictional entities—the major stakeholder in the provision of human services to disaster survivors. This learning will also be used to create OHSEPR's STLT Capabilities Guide.

### B. Desired Outcome

This engagement activity will support the identification of challenges in disaster response for STLT human services programs and activities that may help to improve future human services disaster preparedness and response. Further, this activity will assist OHSEPR to fill knowledge gaps related to the capabilities for states, tribes, local entities, and territories to support human services needs following disasters and emergencies.

### C. Method

The contractor will conduct nine interviews with state, tribal, local, and territorial jurisdictions and human service providers for 90 minutes each. These sessions will be held using an online platform. Participants will engage in the session through polling questions and chat box. In addition, meeting facilitators will encourage candid discussion re: disaster preparedness and response experiences using discussion questions (outlined below). All responses will be anonymous and will not be attributable to a specific individual. Categorical responses will be aggregated.

## II. INTERVIEW

### A. Introduction [5 minutes]

#### 1. Contractor Intro [1-2 minutes]

We are with Lindahl Reed, OHSEPR’s contractor, and we will conduct this interview.

#### 2. Context [3 minutes]

“OHSEPR seeks to learn about state, tribal, local, and territorial (STLT) human services entities’ response to previous emergencies and any issues with service provision during or following a disaster. The purpose of this effort is to develop a capabilities guide to help STLT human services program staff quickly plan, prioritize and act, in future emergency responses. The disasters we are focusing on include the COVID-19 pandemic and other recent disasters such as the 2020 wildfire season on the West Coast, hurricanes Harvey, Irma and Maria in 2017, the Flint water crisis in 2014 and Hurricane Sandy in 2012.”

We will focus on the following areas:

- roles and experience;
- issues and challenges;
- support for STLT;
- prioritizing;
- stakeholders;
- disaster equity; and
- capabilities.

We can skip questions that fall outside your areas of expertise. We encourage you to provide specific examples where possible.”

#### 3. PRA Statement [2 minutes]

“OHSEPR is collecting this information to identify areas of improvement and support for disaster human services planning and operations. This discussion will last approximately 90 minutes. Your participation is voluntary. All information will be kept private. A Federal agency may not conduct or sponsor, and no individual or entity is required to respond to, nor shall an individual or entity be subject to a penalty for failure to comply with a collection of information subject to the requirements of the Paperwork Reduction Act of 1995, unless that collection of information displays a currently valid OMB Control Number. ### **C. Issues, Challenges, and Gaps [15 minutes]**

*We would like to hear about your issues, challenges, and gaps in human services preparedness and response. Preparedness efforts occur before the disaster and may include emergency planning or coordination with emergency management officials. Response efforts refers to providing services during or after the disaster, including immediately or several months after the disaster.*

1. What are your greatest issues, challenges, and gaps, for example, those related to providing services or administering programs:
  - a. When preparing for a disaster? (e.g., coordination with stakeholders and emergency management officials, emergency operations plans, etc.)
  - b. During or following a disaster? (e.g., increased demand for services, serving a population with acute needs, etc.)
    - i. *PROBE*: Do the issues/challenges/gaps change over time (e.g., 6 months after, 18 months after, etc.)? If so, how?
2. How have you addressed these issues/challenges/gaps?

## **D. Support for STLT Human Service Providers [15 minutes]**

*Now we'll focus on what would help you to prepare for or respond to a disaster.*

1. What kinds of resources and support would be most helpful to address these issues, challenges, and gaps?
2. What has helped you prepare for disasters? What would help you prepare for a disaster?
  - a. PROBE: This may include planning activities, training, tools, stakeholder coordination, etc.
3. What has helped you respond to a disaster? What would help you respond to a disaster?
  - a. PROBE: This may include supplemental funding, technical assistance, tools, systems, guidance documents, or coordination with stakeholders.
4. Have program waivers and flexibilities related to federal requirements assisted in response? For example, waivers and flexibilities may include temporary pauses or alternative options related to service delivery, reporting requirements, or other administrative steps in federal programs.
  - a. Have they reduced administrative burden? If so, how?
  - b. Have they expedited service delivery? If so, how?
5. How would you use additional funding for emergency preparedness and response?

## **E. Prioritizing During Response [10 minutes]**

*We understand that competing human services needs or issues may arise during a disaster response.*

1. How have you prioritized human services issues during or after a disaster?

- a. Did it work well?
  - b. Why or why not?
2. What tools/resources (such as technical assistance, systems, a coordinator, outside assistance, guidance documents) would help you prioritize and address these issues?

## **F. Stakeholders [10 minutes]**

*Now we will discuss communicating and coordinating with stakeholders.*

1. Which stakeholders do you communicate or coordinate with during preparedness and response?
  - a. *PROBE*: Which ones are most important?
2. Which stakeholders do you wish you had communicated and/or coordinated with before a disaster? Why?
3. How can coordination with stakeholders help address gaps such as funding, staffing, outreach, etc.?
4. Which stakeholders would be helpful in addressing disruptions to human services delivery?
  - a. Disruptions may include blocked roads, disrupted public transit, closed schools or childcare, and lack of access to internet and phone services.

## **G. Disaster Equity [10 minutes]**

*We would like to discuss how to address equity during disaster response. OHSEPR worked across HHS last year to define disaster equity. Disaster equity is the provision of community-specific services and resources for disaster survivors that are accessible, and culturally and linguistically tailored to mitigate disparities in health and well-being and support resilience.*

1. To what extent does your organization/program try to take an equity approach to disaster response?
  - a. What does that approach look like?
  - b. Has it worked well? Why or why not?
  - c. (if time allows) If you had sufficient resources, what additional equity considerations would you incorporate into disaster response?
2. *If the interviewee is unsure:*
  - a. Who does your program(s) typically serve (e.g., beneficiaries)? How does that compare to the universe of intended beneficiaries?
  - b. Have you collected or identified demographics or characteristics of those who are applying for and being approved or denied for your services?
  - c. Have you been able to identify any barriers to entry for your programs?

- d. After a disaster, does your program do proactive outreach to impacted communities to encourage engagement in your program?
  - i. *PROBE*: What does the outreach look like?
3. To what extent do you believe there is room to improve in the equity-related areas of emergency response?
  - a. If any, what improvements would you like to see and what resources, tools, or information would support those improvements?

## **H. Suggested Capabilities [15 minutes]**

*OHSEPR has developed draft capabilities for STLT human services programs and we'd like to get your feedback.*

**Coalition Building** - forming a coalition of human services agencies and organizations that meet regularly to collaborate and coordinate on preparing for, responding to, and recovering from incidents impacting human services to ensure that disaster survivors receive the most appropriate assistance

**Planning** - documenting authorities and roles and responsibilities; developing an all-hazards emergency operations plan for the equitable, timely, and efficient delivery of post-disaster human services

**Social Vulnerability** - knowing who may need assistance before, during, and after the disaster

**Disaster Equity** - providing community-specific services and resources for disaster survivors that are accessible, and culturally and linguistically tailored to mitigate disparities in health and well-being and support resilience

**Coordination**: working together with stakeholders to provide equitable, timely and efficient delivery of human services following a disaster; and to address service delivery issues

**Communication**: strong, consistent, and effective communication mechanisms between different stakeholders for a well-coordinated disaster response

**Information sharing**: facilitating the exchange and/or dissemination of accurate, relevant, actionable, and timely information about the disaster and the status and needs of the human services delivery system.

**Surge** - assisting a surge of individuals with human services needs during incidents that exceed the limits of the normal human services infrastructure of an affected jurisdiction

**Learning and Evaluation**: practices to assess and improve capabilities for disaster human services
