

#### PRIVACY ACT STATEMENT

Authority: Fish and Wildlife Act of 1956, (16 U.S.C. 742a-742j-I); National Wildlife Refuge System Administration Act of 1966 (16 U.S.C. 668dd *et seq.*); National Wildlife Refuge System Improvement Act, PL 105-57, 111 Stat. 1252;

**Purpose:** The information provided will be used to provide upon request to landowners the setback distances required for the placement of drain tile on lands covered by wetland easements.

## PAPERWORK REDUCTION ACT STATEMENT

In accordance with the Paperwork Reduction Act (44 U.S.C. 3501 *et seq.*), the U.S. Fish and Wildlife Service collects information necessary to provide setback distances to landowners for the placement of drain tile on lands covered by wetland easements.
