

SUPPORTING STATEMENT
FOR PAPERWORK REDUCTION ACT SUBMISSION

- 1. Explain the circumstances that make the collection of information necessary. What is the purpose for this information collection? This request is for an extension of OMB approval of the application package for the Predominantly Black Institutions Competitive (PBI-C) grant program, which expires December 31, 2023. The PBI-C program provides financial assistance to support the strengthening of PBIs to carry out programs in the following areas: science, technology, engineering, or mathematics (STEM); health education; internationalization or globalization; teacher preparation; or improving educational outcomes of African American males.

The authorizing statute for this program, Title III, Part F, Section 371 of the Higher Education Act of 1965, as amended (HEA), requires the collection of information identified in the application package.

The collection of information requested in the application is necessary to permit eligible institutions to apply for grants under the PBI-C program. Further, legislation requires the collection of the data in order for the Secretary to determine awards for each institution and to evaluate each institution's plans for grant funds.

There are no changes to the application since OMB's last review and approval of the form.

This discretionary grant falls under the streamlined grant process, 1894-0001, which waives the 60-day comment period.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

Applications for grants under the PBI-C Program are submitted electronically using the Grants.gov Apply site (Grants.gov). The information collected is gathered electronically through Grants.gov for the Department of Education for the purpose of obtaining programmatic and budgetary information needed to evaluate applications and to make funding decisions based on the authorizing statute and the published selection criteria. This collection will be conducted annually, based on availability of funding for new grants under Title III, Part F, of the HEA.

Notably, without the collection of this information, the Department cannot determine whether applicants for PBI-C grants under Title III meet the qualifications for the grant, and therefore cannot award new grants for which Congress has appropriated funds under this program.

The program staff and peer reviewers will use the information to evaluate applications and make funding decisions.

The collection of information will be 100% electronic, thereby minimizing burden to the fullest extent possible.

4. **Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

The information submitted in each application is unique to each respondent. Moreover, the information changes annually. No other existing information collection can serve the purposes described in item 2.

5. **If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden. The collection of information does not involve small businesses or other small entities.

This application will be used by those applicants that desire to apply for new awards under PBI-C. If this information is not collected, grants cannot be awarded in accordance with the guidelines outlined in the Title III, Part F legislation. If the collection were not conducted annually, appropriated funds could not be spent.

- **requiring respondents to report information to the agency more often than quarterly;**

There are no special circumstances.

This process allows the 60-day comment period to be waived for discretionary grants and that a 30-day comment period will be issued in conjunction with the OMB review.
