1. Is this trip possible as planned? (prompted at notification of trip)

2. Did the trip start on time?
 - a. Yes

 - d. No, due to other reasons (HOS, weather, repower, personal, other)

3. During this stop, how many hours and minutes were spent: *(prompted at each delivery/pickup)*
 - a. Loading or unloading?
 - i. *Time in 15-minute increment options provided ("15 mins", "30 mins", "45 mins", "1 hour", "1:15", "1:30", "1:45", "2 hours")*
 - b. Engaged in active dwell time (including inspecting your vehicle and equipment, securing your load, and completing paperwork like a bill of lading; active dwell time does NOT include waiting?)
 - i. *Time in 15-minute increment options provided ("15 mins", "30 mins", "45 mins", "1 hour", "1:15", "1:30", "1:45", "2 hours")*

4. Did your vehicle hit or almost hit another vehicle or object during your last trip? *(prompted at each delivery/pickup)*
 - a. No

 - c. Yes, at a facility
 - d. Almost, while driving
