	<p>2. Am I required to respond to this survey? Yes, you are required by law to respond to this survey. We are conducting this survey under the authority of Title 13, U.S. Code, Sections 141 and 193. This collection of information has been approved by the Office of Management and Budget (OMB). The eight-digit OMB approval number is 0607-0971. If this number were not displayed, we could not conduct the survey.</p>
