You are not eligible for Extra Help with Medicare prescription drug plan costs. This determination is based on the letter we previously sent you and any additional information you submitted. It is important for you to know you can still enroll in a Medicare prescription drug plan even though you are not eligible for Extra Help.

Why You Are Not Eligible For Extra Help

You are not eligible for Extra Help, because your income is above the limit set by law to qualify for Extra Help.

What To Do If Your Situation Changes

If your situation changes, please call Social Security right away toll-free at 1-800-772-1213 to file a new application.

Medicare Prescription Drug Plans

Even though you are not eligible for Extra Help paying for the costs of a Medicare prescription drug plan, you may still be able to join a drug plan. To find out if you are eligible to join a Medicare prescription drug plan or Medicare Advantage health plan, visit www.medicare.gov on the web. You can also call toll-free at 1-800-MEDICARE (1-800-633-4227). If you are deaf or hard of hearing, you can call the Medicare TTY number toll-free at 1-877-486-2048.

Information Used To Make The Decision

The amount of your Extra Help is based on your marital status, the number of people living in your household, the resources you own, and your income. When you are married and living with your spouse, we count the resources and income for both of you.

You and your spouse have the following resources:

Bank Accounts

Your resources we count are less than \$11,960.00. The enclosed worksheet shows you how we counted your resources.

You have 3 people in your household. When we determine the size of your household, we count you, your spouse (if you are married and living together), and any relative who lives with you and receives at least one-half of their financial support from you or your spouse.

You and your spouse have the following yearly income:

- Social Security benefits (before any Medicare premium deductions) of \$27,494.40
- Other pensions or annuities of \$8,400.00
- Other income of \$8,400.00

Your income we count is 150% or more of the Federal Poverty Level. We count your total yearly income. We converted any monthly income amounts you gave us to a total yearly income amount. The enclosed worksheet shows you how we counted your income.

If You Disagree With The Decision

If you disagree with the decision, you have the right to appeal. We will provide you with a hearing by telephone or a case review. We will look at any new information you have. The person who will conduct the hearing or case review had no prior involvement in the first decision. We will review those parts of the decision which you believe are wrong and will look at any new facts you have. We may also review those parts which you believe are correct and may make them unfavorable or less favorable to you.

If you want this appeal, either by a hearing or a case review, you may request it by calling toll-free 1-800-772-1213.

- You have 60 days to ask for an appeal.
- The 60 days start the day after you get this letter. We assume you got this letter 5 days after the date on it unless you show us that you did not get it within the 5-day period.
- You must have a good reason for waiting more than 60 days.
- You can call to request an appeal. You can also obtain a copy of the form SSA-1021, "Request for Appeal of Determination for Help with Medicare Prescription Drug Plan Costs" from www.socialsecurity.gov. Contact us if you need help.

If You Want Help With Your Appeal

You can have a representative, friend or someone else help you with your appeal. Your local Social Security office has a list of groups that can help you. These groups can find a representative or give you free legal services if you qualify. There also are representatives who do not charge unless you win your appeal.

Information About Medicare Savings Programs

Unless you told us not to, we will share information with your State. This will start your application process for a Medicare Savings Program which can help you with your medical costs. The additional help from these Medicare Savings Programs can be worth more than \$1,326.00 a year.

How You May Be Able To Receive SSI

It does not appear that you are eligible for Supplemental Security Income (SSI) benefits. However, you may still want to file an SSI application if you have not already done so. If you file an SSI application, you will receive a formal decision about your eligibility. If you do not agree with the decision, you may appeal.

If you decide to file for SSI, it is important that you get in touch with Social Security right away. You can call us toll-free at 1-800-772-1213. The sooner you file for SSI, the sooner you may begin receiving benefits. If you wait more than 60 days from the date of this notice to apply for SSI you could be losing SSI benefits.
