People with Medicare who want to join a Medicare Advantage Plan or Medicare Prescription Drug Plan

### To join a plan, you must:

- Be a United States citizen or be lawfully present in the U.S.
- Live in the plan's service area

- Medicare Part A (Hospital Insurance)
- Medicare Part B (Medical Insurance)

**Important:** To join a Medicare Prescription Drug Plan, you must also have either, or both:

- Medicare Part A (Hospital Insurance)
- Medicare Part B (Medical Insurance)

# When do I use this form?

You can join a plan:

- Between October 15–December 7 each year (for coverage starting January1)
- Within 3 months of first getting Medicare
- In certain situations where you're allowed to join or switch plans

# What do I need to complete this form?

- Your Medicare Number (the number on your red, white, and blue Medicare card)

- If you want to join a plan during fall open enrollment (October 15–December 7), the plan must get your completed form by December 7.
