A separate Form I-864A must be used for each household member whose income and/or assets are being used by a sponsor to qualify. Each Form I-864A is completed and signed by two individuals: a sponsor who is completing Form I-864 and a household member who is promising to make his or her income and/or assets available to the sponsor to help support the sponsored immigrants. The combined signing of this contract constitutes an agreement that the household member is responsible along with the sponsor for the support of the individuals named in this contract.</p> <p>This contract must be submitted with Form I-864.</p> <p>Form I-864A may only be used when a sponsor’s income and assets do not meet the income requirements of Form I-864 and the qualifying household member chooses to combine his or her resources with the income and/or assets of a sponsor to meet the requirements. A separate Form I-864A must be used for each household member whose income and/or assets are being used by a sponsor to qualify. Each Form I-864A <b>must be</b> completed and signed by two individuals: <b>the</b> sponsor who is completing Form I-864 and a household member <b>of the sponsor</b> who is promising to make his or her income and/or assets <b>available to</b> help support the sponsored <b>immigrant(s)</b>. The combined signing of this contract constitutes an agreement that the household member is <b>jointly</b> responsible, along with the sponsor, for the support of the <b>individual(s)</b> named in this contract.</p> <p><b>Form I-864A</b> must be submitted with Form I-864.</p> <p>Form I-864A may only be used when a sponsor’s income and assets do not meet the income requirements of Form I-864 and the qualifying household member chooses to combine his or her resources with the income and/or assets of a sponsor to meet the requirements.
