## Introduction

## How to use this spreadsheet:

Each worksheet in this document represents a template for one type of claim line item. Each row should contain one line item of the type specified for the tab. Each column has a specified data type as described below.

## Data Types:

Text	An alphanumeric value. Limited to the length specified on the spreadsheet.
Money	A number with up to 13 digits to the left of the decimal, and two to the right.
Integer	A number with no decimal. Limited from 0 to 2,147,483,647.
InterestRate	A number with 2 digits to the left of the decimal, and 4 to the right.
Date	A date in the format MM/DD/YYYY.
