If you know of particular individuals you would like to work with, you may, if you wish, contact them to express your interest in their work and to let them know that you have an application online, complete and waiting to be reviewed. To find information on research currently being conducted at the NIH, visit the NIH website, http://www.nih.gov/.

If you have a specific research interest, you can identify relevant research projects by going to the NIH Annual Reports, http://intramural.nih.gov/search/, and searching on topics that interest you. Alternatively, you can visit the Intramural Research Program website, NIH-IRL-URL-ADDRESS, where NIH investigators are grouped by research interest. You can then contact the principal investigators directly. You will find contact information for the principal investigators in the NIH Enterprise Directory, http://ned.nih.gov.

You can check the status of your letters of recommendation, update/modify your reference information, and resend the requests for a letter of recommendation at the NIH Application Center, NIHAC-URL-ADDRESS.
