Apprentice Trailblazer Application

The Apprentice Trailblazer Initiative is designed to create a national network of diverse apprentices and apprenticeship graduates of all ages and backgrounds to feature their stories and hear their perspectives, show how Registered Apprenticeships increase opportunities for underserved populations, and bring awareness to other career seekers who may be interested in becoming apprentices.

A key goal for the first cohort of Apprentice Trailblazers is to focus on youth and create a national network of current youth apprentices (i.e., registered apprentices who are aged 16-24) who have been apprentices for at least 6 months and recent youth apprenticeship graduates (graduates) who have completed their Registered Apprenticeship program within the past 3 years. These youth Apprentice Trailblazers will serve as champions for Registered Apprenticeship by sharing their success stories and promoting Registered Apprenticeship through outreach to youth and others. The Department of Labor's Office of Apprenticeship is interested in hearing from all apprentices/graduates, especially youth, regarding ideas and suggestions on how to continue to promote, expand, diversify, and strengthen Registered Apprenticeship based on their experience.

Serving as an Apprentice Trailblazer is a professional development opportunity. Apprentice Trailblazers will exercise valuable skills such as teamwork, leadership, and public speaking. They will also have the opportunity to network with stakeholders, engage with Apprenticeship Ambassadors, and cultivate mentor relationships.

*Items noted with an asterisk below require a response.

Criteria: In order to be an Apprentice Trailblazer in the first cohort focused on youth, an applicant must:

- Be a current youth apprentice (ages 16-24) in a Registered Apprenticeship program for at least 6 months or recent youth
 apprenticeship graduate within the past 3 years from the date the application is submitted;
- Be an apprentice/graduate from a Registered Apprenticeship program in good standing who has shown exemplary leadership, mentoring, teamwork, promotional activities, and/or has a transformative story as an apprentice;
 - Examples of exemplary <u>leadership</u> include but are not limited to starting a peer group to connect apprentices; using social
 media and other avenues to share their apprenticeship experience and promote Registered Apprenticeship; displaying
 leadership characteristics during their apprenticeship such as exercising critical thinking, strong decision making skills, and
 operating as a self-starter; and providing useful feedback on how to improve apprentice experiences such as ways to advance
 diversity, equity, inclusion, and accessibility and also increase apprenticeship completion rates.
 - Examples of <u>mentoring</u> include but are not limited to serving as a peer mentor during their apprenticeship; serving as a
 mentor to incoming apprentices and/or prospective apprentices once becoming an apprenticeship graduate; and serving as a
 mentor to youth in their community with respect to career development.
 - Examples of <u>teamwork</u> include but are not limited to actively participating in a study group with other apprentices;
 successfully completing group assignments; and working cooperatively with peers, mentors, supervisors, and/or other colleagues to accomplish tasks.
 - Examples of <u>promotional activities</u> include but are not limited to engaging in outreach and developing new ways to promote, diversify, and expand Registered Apprenticeship.
 - Examples of a <u>transformative story</u> include but are not limited to apprentices that have overcome substantial obstacles while
 working as an apprentice or have succeeded in advancing their career or quality of life through a Registered Apprenticeship.

- Make a year-long commitment to promote Registered Apprenticeship from the date of appointment as an Apprentice Trailblazer (see Menu of Outreach Activities and Core Expectations below);
- Be currently working in an industry/occupation similar to that in which they completed their Registered Apprenticeship program
 (if an apprentice graduate);
- Submit a complete application with responses to all required fields and include both the signature of the apprentice/graduate and signature from their Registered Apprenticeship employer; and
- Have a parent/legal guardian provide written authorization for the apprentice/graduate to participate in the Initiative, if the
 apprentice/graduate is under 18 years of age and is not emancipated.

At any time, the apprentice/graduate, the apprentice/graduate's Registered Apprenticeship employer, or the apprentice/graduate's parent/legal guardian (if the apprentice/graduate is under age 18 and not emancipated) may request to remove the apprentice/graduate's application from consideration or request the apprentice/graduate's withdrawal from participation in the Initiative

Core Expectations for an Apprentice Trailblazer:

- Apprentice Trailblazers may have their name, title, and the name of their Registered Apprenticeship employer publicized on the
 <u>www.apprenticeship.gov</u> website and included in press releases.
- · Apprentice Trailblazers will attend a kick-off event, either virtually or in-person.
- . Apprentice Trailblazers will attend quarterly virtual meetings with DOL Office of Apprenticeship.
- Apprentice Trailblazers will have opportunities to share their perspectives on Registered Apprenticeship and their program
 experiences
- · Apprentice Trailblazers are expected to complete at least one outreach activity from the Menu of Outreach Activities below.
- Apprentice Trailblazers will work closely with their Registered Apprenticeship employer, who will oversee their participation in the
 Apprentice Trailblazer Initiative and help coordinate completion of any selected outreach activities and these core expectations.
- Apprentice Trailblazers are expected to maintain professionalism, open communication, and transparency with their Registered Apprenticeship employer and DOL Office of Apprenticeship with respect to their participation in this Initiative.
