U.S. Customs & Border Protection e-Recordation Program

How to Obtain Border Enforcement of Trademarks and Copyrights

United States Customs and Border Protection (CBP) has the authority to detain, seize, forfeit, and ultimately destroy merchandise seeking entry into the United States if it bears an infringing trademark or copyright that has been registered with the United States Patent and Trademark Office (USPTO) or the United States Copyright Office (USCO), and has subsequently been recorded with CBP. As an Intellectual Property Right (IPR) owner, you can partner with CBP to receive border enforcement of your registered trademarks and copyrights through CBP's e-Recordation Program.

Required Documents

We recommend that you have the following materials and information readily available before you begin the application process:

- U.S. Patent & Trademark Office Registration Certificate, U.S. Copyright Office Registration Certificate, or proof of an application with the U.S. Copyright Office
- Digital images of the trademark or copyright as used in commerce in ".jpg", ".gif" or ".pdf" format. Please note that individual image files are limited to 2MB.
- Name, address, telephone number and email address of a Point of Contact that will be available to CBP should they have questions concerning border enforcement of the recordation.
- List of authorized manufacturers, licensees and parties authorized to use the trademark, if applicable.
- Countries of manufacture.

Optional Documents


We also recommend that you submit additional information through the application that will assist CBP in enforcing your trademark and/or copyright at the border:

- Authentication:** An authentication manual that describes your trademark and/or copyright, introduces your brand and provides detailed images of your genuine goods and how to differentiate them from unauthorized merchandise. All guides will be reviewed by the Intellectual Property Enforcement Branch in IPR and must comply with the Template.


Eligibility & Fees

- ▼ Trademark

In order to record with CBP you must have a valid trademark registration published on the Principal Register of the United States Patent and Trademark Office (USPTO). The fee for e-Recordation is \$190 per International Class of Goods (IC), per trademark registration. The recordation will remain in force concurrently with the underlying USPTO registration, if renewed along with the USPTO registration.


- ▼ Copyright


In order to record with CBP you must have a valid copyright registration with the United States Copyright Office (USCO). The fee for e-Recordation is \$190 per copyright. The recordation will remain in force concurrently with the underlying copyright registration, if renewed with CBP every 20 years.


- ▼ Pending Copyright

You may record pending copyright registrations for a period of 6 months by emailing IPRRQuestions@cbp.dhs.gov and providing proof that you have filed an application with the United States Copyright Office (USCO).
- ▼ Renewal

Recordations can be renewed for another term for the fee of \$80 per International Class of Goods (IC) for trademarks, and \$80 per copyright.
- ▼ Expiration

A right holder has a 90-day grace period from the time of the USPTO expiration date to renew their recordation. Beyond this 90-day period, should the right holder wish to continue to receive border enforcement, they will have to apply anew and pay the standard fee for new recordations. The IPR Database reflects the expiration date of the CBP Recordation, which already factors in the 90 day grace period from the time of the USPTO expiration date.



Gray Market Restriction

Trademarks that are recorded with CBP are eligible for gray market protection where:

- (1) the U.S. and foreign trademarks are not owned by the same person, and
- (2) the U.S. and foreign trademark owners are not a parent or subsidiary, or otherwise subject to common ownership or control.

See 19 C.F.R. §133.23.

The recordation holder must apply for such protection with the Intellectual Property Enforcement (IPE) Branch of Regulations & Rulings at HQIPR@cbp.dhs.gov.

Trademarks that are not eligible for gray market protection because of common ownership or control between the U.S. owner and a foreign owner may request that CBP restrict the importation of gray market goods which are "physically and materially different" from goods intended for sale within the U.S. by requesting [Lever-Rule](#) protection. See *Lever Brothers Co. v. U.S.*, 98 F.2d 1330 (9th Cir. 1939). To qualify for this type of protection the trademark registration must be owned, or jointly owned, by a U.S. citizen. Trademark recordation holders who wish to obtain Lever-Rule protection for specific products must make a request to HQIPR@cbp.dhs.gov and (1) state the basis for this claim with particularity; (2) support the claim by competent evidence; and (3) provide CBP with a summary of the alleged physical and material differences that exist between the merchandise authorized for sale in the United States and those intended for other markets. "Physical and material" differences between merchandise authorized for sale in the United States and those intended for other markets may include, but are not limited to:

- The specific composition of both the authorized and gray market product(s) (including chemical composition)
- Formulation, product construction, structure, or composite product components, of both the authorized and gray market product
- Performance and/or operational characteristics of both the authorized and gray market product
- Differences resulting from legal or regulatory requirements, certification, etc.
- Other distinguishing and explicitly defined factors that would likely result in consumer deception or confusion as proscribed under applicable law

Making Changes to your Recordation

All guides will be reviewed by the Intellectual Property Enforcement Branch in RR and must comply with the Template.

Training: CBP offers recordation holders the opportunity to provide enforcement-oriented training to CBP personnel in the field. Training may be conducted virtually or in person at the Port of Entry. All training materials will be reviewed and vetted, and must comply with the requirements identified in the Best Practices Document. To request a training please email trademans@cbp.dhs.gov.

E-ALLEGATIONS

Online Trade Violation Reporting System

Information regarding suspect shipments or parties importing infringing merchandise should not be submitted through the e-Recordation Program, but instead, should be directed to e-Allegations Online Trade Violation Reporting System.

Public versions of CBP recordations are available online via the Intellectual Property Rights Search System (IPRS).

IPRS Internal Database

The Intellectual Property Rights Internal Search System (IPRS) contains all of the information submitted by the right holder, and is only accessible by CBP personnel and other U.S. government personnel that have a need to know.

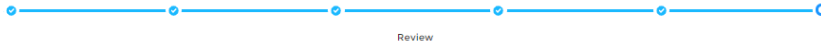
