Dear NRT Participant,

We hope you are well. We are writing to remind you that you received an email from NRT Tech Support about setting up your account and completing a survey when your PI or Coordinator opened the report for data entry. The Welcome Email contains a registration link that you need to click to confirm your email address. Once you've done that, you will receive a time-sensitive email prompting you to create a password. After completing these tasks, you can log in to <https://reporting.nrt.nsf.gov> and complete your personnel survey.

If you are a Co-PI or Faculty member, you will enter or update your Contact and Demographic information, and you can expect to give 8-10 minutes of your time. Trainees will enter more information about their experiences as part of the NRT project for the current reporting period, and most Trainees take around 30-45 minutes to complete their surveys.
