- When you click on the **Analyze** button you will be opening a Microsoft Excel file
- The Analysis report is not available for all forms
- The Analysis report is different for the forms in which it exists
- The example to the left shows a report with several tabs
- Each tab will display analysis information about a different part of the form
- The “analysis” is the display of historical trends, and in some cases elements like percent difference, that can assist users in identifying if data are inconsistent with previous data
- **ALL Data Entry** users are strongly advised to examine the Analysis Sheet prior to submitting every form as an added safeguard against incorrect
