PLEASE NOTE: If you plan to fish in ANY state or U.S. territory EXCEPT Hawaii, Puerto Rico, or the U.S. Virgin Islands, it is very likely that the state will require you to obtain a saltwater recreational fishing license or registration for your fishing activity, in which case you will be AUTOMATICALLY registered with the National Saltwater Angler Registry and should NOT register here.

An individual angler registration covers only one angler. If you would like to register more than one angler, you will need to complete a separate registration for each angler.
