Welcome to the Flight Training Security Program (FTSP) for Flight School Candidates!

Here, you can create an online account on TSA's online portal for the Flight Training Security Program. You will be asked to submit an application providing basic information about yourself and about the training you would like to receive. After you have submitted the application, TSA will notify the flight training provider at the location you have selected. The provider will submit a Flight Training Request on your behalf and confirm to TSA that you have made arrangements to train at that location.

Once TSA has verified your information with the flight training provider, you will receive an email with instructions on how to pay the fee to TSA. TSA will not issue any fee refunds, unless a fee was paid in error.

Do not use your web browser's page forward and backward arrows; this may cause data loss or program failure. TSA recommends you use Microsoft Edge as your browser for optimum performance on this portal.

Manage My Personal Account Information

To begin this process, select 'Update Personal Information.' You will be asked to provide information such as your name, birth date, citizenship, and other biographical information. To complete each step, click on the link on the right, which will take you to the next step. You must click the 'Save' button at the top of the screen before you proceed to the next step. The links on the left of your screen allow you to see the progress of your application throughout the process (✓ indicates information accepted; * indicates information still required).
