PURPOSE: ODDS is an Internet-based system used to facilitate observer and electronic monitoring (EM) deployment on vessels. ODDS also is used to facilitate communication among the vessel owners or operators, NMFS, and the observer provider or EM provider. ROUTINE USES: The primary use for ODDS is for owners or operators of vessels in the trip selection pool to log their fishing trips so that NMFS can determine if a particular fishing trip is randomly selected for observer or EM coverage. In addition to logging fishing trips, the owners or operators of some vessels may use ODDS to request placement in either the full coverage category or electronic monitoring.\_
