

Variable Name	Description
jurisdiction	The name of the local jurisdiction
quarter	The one-digit value corresponding to the quarter of the calendar year (1=Jan-Mar, 2=Apr-Jun, 3=Jul-Sept, 4=Oct-Dec).
year	The four-digit calendar year (e.g., 2024)
entry_point	Setting where individuals with a treatment need for opioid use/Opioid Use Disorder or stimulant use/Stimulant Use Disorder are identified.
substance_type	The specific category of substance use or substance use disorder (Opioid Use Disorder or Stimulant Use Disorder) that prompts the recognition of a treatment need or the need for linkage to care.
sex	Four categories: Total, Male, Female, Missing
age_group	Eleven categories: Total, 0-14 years, 15-24 years, 25-34 years, 35-44 years, 45-54 years, 55-64 years, 65-74 years, 75-84 years, 85 years and up, missing

race	Ten categories: Total, American Indian or Alaska Native, Asian, Black or African American, Middle Eastern or North African, Native Hawaiian or Pacific Islander, White, Multiple race, Other race, Unknown or Missing
ethnicity	Four categories: Total, Hispanic/Latino, non-Hispanic/Latino, Unknown or Missing
identified_n	The number of persons identified with a treatment need during the reporting period.
engaged_n	Among those identified with a treatment need during the reporting period, the number of persons engaged by linkage to care program staff.
refer_anytx_n	Among those identified with a treatment need during the reporting period, the number of persons who were referred to MOUD or behavioral treatment.
refer_MOUD_n	Among those identified with a treatment need during the reporting period, the number of persons who were referred to MOUD.
refer_behav_n	Among those identified with a treatment need during the reporting period, the number of persons who were referred to behavioral health treatment.
refer_harmred_n	Among those identified with a treatment need during the reporting period, the number of persons who were referred to harm reduction services.
initiate_anytx_n	Among those identified with a treatment need during the reporting period, the number of persons who were successfully linked to MOUD or behavioral health treatment (e.g. initiated MOUD or behavioral health treatment).
initiate_MOUD_n	Among those identified with a treatment need during the reporting period, the number of persons who were successfully linked to MOUD (e.g. initiated MOUD).
initiate_behav_n	Among those identified with a treatment need during the reporting period, the number of persons who were successfully linked to behavioral health treatment (e.g. initiated behavioral health treatment).

initiate_harmred_n	Among those identified with a treatment need during the reporting period, the number of persons who were successfully linked to harm reduction services (e.g. initiated harm reduction services).
status_MOUD_retain_n	Among those identified with a treatment need during the reporting period who were linked to MOUD, the number of persons who are <u>retained in treatment</u> 6 months after initiating MOUD treatment.
status_MOUD_compl_n	Among those identified with a treatment need during the reporting period who are linked to MOUD, the number of persons who <u>completed treatment</u> within 6 months after initiating MOUD treatment.
status_MOUD_lost_n	Among those identified with a treatment need during the reporting period who are linked to MOUD, the number of persons who were <u>lost to follow-up</u> (e.g., did not complete the treatment program and are no longer active in treatment) within 6 months after initiating MOUD treatment.
status_MOUD_incarc_n	Among those identified with a treatment need during the reporting period who are linked to MOUD, the number of persons who are <u>incarcerated</u> 6 months after initiating MOUD treatment.
status_MOUD_decd_n	Among those identified with a treatment need during the reporting period who were linked to MOUD, the number of persons who are <u>deceased</u> 6 months after initiating MOUD treatment.
status_MOUD_oth_n	Among those identified with a treatment need during the reporting period who were linked to MOUD, the number of persons who had <u>another known status</u> 6 months after initiating MOUD treatment.
status_MOUD_unkn_n	Among those identified with a treatment need during the reporting period who were linked to MOUD, the number of persons who had <u>unknown status</u> 6 months after initiating MOUD treatment.
status_behav_retain_n	Among those identified with a treatment need during the reporting period who were linked to behavioral treatment, the number of persons who are <u>retained in treatment</u> 6 months after initiating behavioral treatment.
status_behav_compl_n	Among those identified with a treatment need during the reporting period who were linked to behavioral treatment, the number of persons who <u>completed treatment</u> within 6 months after initiating behavioral treatment.

status_behav_lost_n	Among those identified with a treatment need during the reporting period who are linked to behavioral treatment, the number of persons who were <u>lost to follow-up</u> (e.g., did not complete the treatment program and are no longer active in treatment) within 6 months after initiating behavioral treatment.
status_behav_incarc_n	Among those identified with a treatment need during the reporting period who were linked to behavioral treatment, the number of persons who are <u>incarcerated</u> 6 months after initiating behavioral treatment.
status_behav_decd_n	Among those identified with a treatment need during the reporting period who were linked to behavioral treatment, the number of persons who are <u>deceased</u> 6 months after initiating behavioral treatment.
