- (3) identify districts that use a food service management company
- (4) let us know whether there are any unique situations that would make it difficult for a specific SFA to participate in the study (for example, the SFA is being audited).

**We have attached an Excel example template for your reference, but the requested information can be provided in whatever format is easiest (such as an export from your own systems). You may also send us information on all of your SFAs instead of just the sampled ones if that is easier. Please reply to this email with the requested data.**
