

FHWAR Eligibility Screener for Cognitive Testing

The survey is online, and to test it, we would like to be on the phone with you as you take it. That way, we can see if you have any problems and ask for your suggestions for improvement. The process will take about 60 minutes and you will be paid \$50 in compensation.

Your answers will always be kept private, and none of the information that we collect about you will be used for any purpose other than research. AFWA will not receive your name or any other identifying information about you. Also, your participation is completely voluntary and you may choose to skip any questions the interviewer asks or stop participating at any time.

If you think you'd like to be in the study, I can ask you a few questions to confirm your eligibility to participate. Would you like me to do that now?
