The undersigned certifies to the Colorado Potato Administrative Committee (Committee), the United States Department of Agriculture, and the Colorado Commissioner of Agriculture, that these potatoes are designated for food use and/or quantities over 1,000 pounds will not be used for seed. These potatoes are exempt from grade, size, maturity, and inspection requirements prescribed under the Marketing Order Handling regulations for the San Luis Valley. These potatoes are subject to Marketing Order fee assessments as approved by the Commissioner, Colorado Department of Agriculture, and the United States Department of Agriculture. False certification, knowing it to be false, is a violation of title 18, section 1001, of the United States Code, among other statutes, which provide for a fine, imprisonment, or both.
