



## Instructions for Completion of Denominators for Neonatal Intensive Care Unit (NICU) (CDC 57.116)

Data Field	Instructions for Data Collection
Facility ID #	The NHSN-assigned facility ID will be auto-entered by the computer.
Location code	Required. Enter the location code of the unit where you collect the data.
Month	Required. Record the 2-digit month during which the data were collected for this location.
Year	Required. Record the 4-digit year during which the data were collected for this location.
Birthweight Categories	Required. The birthweight categories are as follows: A = $\leq 750$ g; B = 751-1000 g; C = 1001-1500 g; D = 1501-2500 g; E = $> 2500$ g. Data on this form are stratified by this category.
Number of patients (Pts)	Required. For each day of the month selected, record the number of patients in each birthweight category on the unit. Record this number at the same time each day.
Number of patients with a central line (CL)	<p>Conditionally required. Complete if you have chosen central line-associated bloodstream infection (CLABSI) as an event to follow in your Plan for this month for this unit. All patients with 1 or more central line(s) in place at the time of the count are included in the denominator regardless of the number of days the central line has been in place (i.e., central line day 1 and day 2 are included in the denominator count). Use the manual data collection method, to collect this data or capture the data electronically, as below:</p> <p>Manual Method:</p> <p>For each day of the month, at the same time each day, record the number of patients in each birthweight category on the selected unit who have 1 or more central line(s). Central line days are counted beginning with the date of insertion or, if the infant is admitted with a permanent line in place, the first day of access and continuing until the line is physically removed or the patient is discharged from the facility. “Access” is defined as line placement, infusion or withdrawal through the line. At the end of the month, total the daily counts and record the sums by birthweight category for the month, in the NHSN system for Central Line Days under the option to Add Summary Data.</p> <p>Electronic Capture:</p> <p>For <u>any</u> location, when denominator data are available from electronic sources (e.g., central line days from electronic charting), these sources may be used as long as the counts are not substantially different (+/- 5%) from manually-collected, once a day counts, pre-validated for a minimum of three months.</p>

<p>Number of patients on a ventilator (VNT)</p>	<p>Conditionally required. Complete if you have chosen Pediatric Ventilator Associated Event (PedVAE) as an event to follow in your Plan for this month for this unit.</p> <p>This field can optionally be completed even though Ventilator Associated Pneumonia (PedVAP) surveillance cannot be included in your plan in a NICU location.</p> <p>All patients on a ventilator at the time of the count are included in the denominator regardless of eligibility for inclusion in PedVAP surveillance (i.e., ventilator day 1 and day 2 are included in the denominator count). Number of patients with 1 or more central lines	Conditionally required. All patients with 1 or more central line(s) in place at the time of the count are included in the denominator regardless of the number of days the central line has been in place (i.e., central line day 1 and day 2 are included in the denominator count).
