National ALS Registry Texas Gift Card Program

To encourage more people to enroll in the National ALS Registry and complete the risk factor surveys, the Registry is pleased to offer a gift card as a token of appreciation for the time and effort it takes to participate in this valuable research project.

The pilot program is open March 1, 2025 - Nov. 30, 2025. People living with ALS who join the Registry and participate in the gift card pilot program can qualify to receive a \$50 gift card to enroll and a \$100 gift card when all of the risk factor surveys have been completed. Please note enrollment and risk factor surveys must be completed within 60 days of signing up for the program (the date this form is submitted). Completing the sign up form and submitting it online is required to qualify for the gift card.

The CDC must confirm enrollment and completion of risk factors during the pilot's open period in order to qualify to receive the gift card. If you need assistance with enrollment and completing the risk factor surveys, please contact your Care Services professional with The ALS Association.

A choice of Visa, Amazon, or Walmart **electronic** gift cards are offered. An email from [Tremendous.com](https://www.tremendous.com) will be sent to the email used to enroll in the Registry with a link to redeem gift cards. The link expires after five years. Once redeemed, the electronic Visa card expires after six months. The electronic Amazon and Walmart cards never expire. There are no activation fees or non-use charges.
