Summary of Changes from Previously Approved Collection

- 35% Exemption Request From 85/15 Reporting Requirement.
- o There are no changes to the form during this submission other than updating the respondent burden paragraph based on the newly received template format and changing the first word of the title from the word "Application" to the word "Request".
- o The form is fillable and available electronically.
- o At this time, the form continues to be submitted to VA via email.
- o The burden has increased since the inception and initial approval of this relatively new collection. Based on the data collection received for calendar years 2022 and 2023 there has been an increase in the number of average annual 35% exemption request instruments received. The Program Office did not start receiving the instruments until after November 2021. This information collection request has therefore been entered into ROCIS as a "Revision" due to the increase in burden hours.
- o One anonymous comment received during the 60-day comment period.

A. Justification:

 Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

The Department of Veterans Affairs (VA) is authorized to pay education benefits to Veterans and other eligible persons pursuing approved programs of education under chapters 30, 32, 33, and 35 of title 38 U.S.C., and chapter 1606 of title 10, U.S.C. As part of the benefits authorization process, Code of Federal Regulations (CFR) title 38 Section 21.4201 places restrictions on enrollment based on the percentage of students receiving financial support in any approved program. Except as otherwise provided by regulation, VA shall not approve an enrollment in any course for an eligible Veteran, not already enrolled, for any period during which more than 85 percent of the students enrolled in the

course are having all or part of their tuition, fees or other charges paid for them by the educational institution or by VA under title 38, U.S.C., or under title 10, U.S.C. This is known as the 85/15 Rule and is applicable to Institutions of Higher Learning (IHLs) and Non-College Degree postsecondary schools.

The requirements apply to all courses, not otherwise exempt, or waived, offered by all educational institutions, regardless of whether the institution is degree-granting, proprietary profit, proprietary nonprofit, eleemosynary, public and/or tax-supported. Schools are required to submit information necessary to determine if their programs of training are approved for the payment of VA educational assistance. This specified information is submitted either to VA or to the State Approving Agency (SAA) having jurisdiction over that school.

This regulation includes a provision that permits an exemption from routine reporting of this data for schools that assert that the number of VA beneficiary students in all programs approved for GI Bill never exceeds 35% of the total enrollment at the educational institution. If approved, such non-accredited schools must still monitor and collect the data, but are exempt from routinely reporting it to VA.

2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

The VA uses data from this information collection to determine that non-receipt of the routine reporting of 85/15 data is authorized by non-accredited schools. Non-accredited schools with an approved exemption are required to provide the complete 85/15 data during regular, periodic compliance survey reviews by VA to ensure no more than 85% of students in any approved program are students in receipt of financial support from the educational institution or by VA under title 38, U.S.C., or under title 10, U.S.C. Without this information, VA might pay benefits in error.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

Information technology is being used to reduce the burden to the extent currently possible. This form is available as a fillable PDF document and is submitted to VA

via email. Most schools utilize financial aid software packages that allow VA beneficiary data to be sorted/reported when appropriately categorized. This allows the school to readily identify affected VA students among the total student population in receipt of financial aid.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

The information obtained through this collection is unique and is not already available for use or adaptation from another cleared source.

This information collection does not impose a significant economic impact on a substantial number of small businesses or entities.

There are no consequences to Federal program or policy activities without this collection other than directly violating 38 CFR Section 21.4201.

General Comment

Requiring schools who have the 35% exemption to still do the 85/15 calculations is ridiculous. What is the point of the exemption then? For a lot of public IHLs, one student could throw a program out of compliance when it only have 50 total students. Please reconsider and stop reviewing and changing policy on this topic and allow it to work how it's intended.

VA Response: VA agrees with the anonymous commenter and have therefore updated the Supporting Statement-A and 30-day FRN to reflect the change that the 85/15 calculations are still required for non-accredited schools.

contained in the Privacy Act Issuances, 2012 Compilation.

There was a total of 5,645 collections of the "35% Exemption Request From 85/15 Reporting Requirement" instruments received for calendar years 2022 and 2023, resulting in an average annual receipt of 2,822 responses. The result calculates to a total of 1,411 burden hours.

- a. Number of Respondents: 2,822.
- b. Frequency of Response: Annually.
- c. Annual Burden Hours: 1,411 (2,822 X 30 minutes / 60 minutes).
- d. Estimated Completion Time: 30 minutes.
- e. The respondent population for VA Form 22-10216 is comprised of School Certifying Officials who are otherwise required to periodically report 85/15 information to the VA. This form exempts the routine reporting to VA only, not collection of the information. VBA cannot make further assumptions about the population of respondents because of the variability of factors such as

educational background and wage potential of respondents. Therefore, VBA used general wage data for "All Occupations" to estimate the respondents' costs associated with completing the information collection.

The Bureau of Labor Statistics gathers information on full-time wage and salary workers. According to the latest available BLS data, the median weekly earnings of full-time wage and salary workers is \$1,259.20. Assuming a forty (40) hour work week, the median hourly wage is \$31.48 based on the BLS wage code of "00-000-0000 for "All Occupations." This information was taken from the following website https://www.bls.gov/oes/current/oes_nat.htm., May 2023.

Legally, respondents may not pay a person or business for assistance in completing the information collection and a person or business may not accept payment for assisting a respondent in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$44,418.28 (1,411 burden hours X \$31.48 per hour).

There are no annualized costs to respondents other than the labor burden costs addressed in Section 12 of this document to complete this collection.
