






Training Screen

This is the screen shown to system users when they open a Training record.




Redemptions Screen

This is the screen shown to system users when they open a Redemption record.




Investigation Screen

This is the screen shown to system users when they open an Investigation record.




Violation Screen

This is the screen shown to system users when they open a Violation record.




Sanction Screen

This is the screen shown to system users when they open a Sanction record.




Create Hours of Operation
