

## **Pathways to Work Evidence Clearinghouse Website- Customer Service Feedback Survey**

We propose to use Touchpoints ([Touchpoints - Product Overview \(v2\) \(digital.gov\)](#)), a .gov platform provided as a shared service by the U.S. General Services Administration, to administer the customer service feedback survey.

Touchpoints has multiple options, but we propose to embed the survey within the Pathways to Work website. This option will add a small tab in the lower right of the screen that says, "Click here to leave feedback." (See Exhibit A.)

This will pop up a small modal window (see Exhibit B) within the Pathways website that would take the individual through a series of 6 questions for which we have the following proposed language:

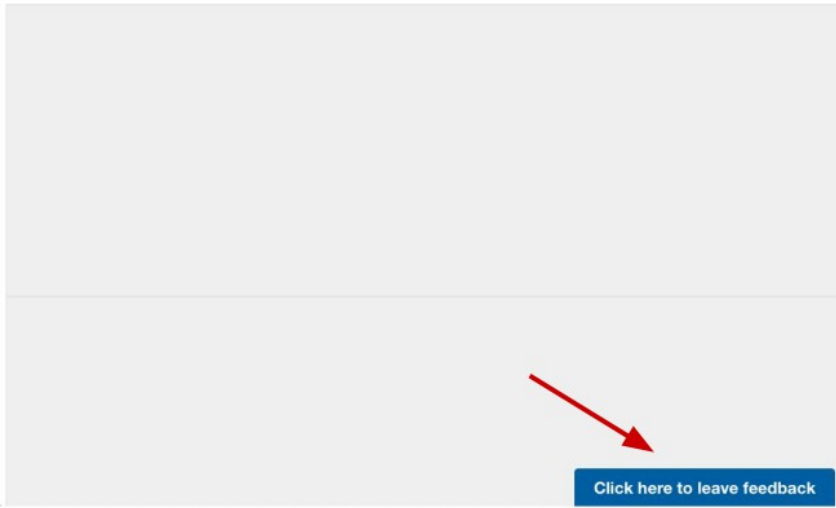
