In accordance with 30 CFR 1206.172(e), form ONRR-4411 is used by the reporter in determining the minimum value for royalty purposes of gas sold beyond the first index pricing point. Refer to 30 CFR 1206.172(e)(3) for calculating the safety net price, 1206.172(e)(4) for calculating the safety net differential, and 1206.172(e)(5) for calculating additional royalties owed.

**Safety Net Report  
Form ONRR-4411 Line-  
by-Line Instructions**

1. Enter the payor's name, address, and payor code used to report royalties on the Report of Sales and Royalty Remittance (form ONRR-2014).
2. Enter the review period in which the safety net price, index value, and safety net differential are being reported on the form ONRR-2014.
3. Enter the name of the index zone.
4. Enter the name of the index pricing point within the index zone.
5. Enter the year in which the safety net price, index value, and safety net differential are being reported on the form ONRR-2014.
6. Enter the preparer's signature, phone number, and date signed.
