

## Digital Signature 508 Compliancy

### Digital Signature Scenario 1:



- Applicant checks “if unable to use mouse or touchscreen to enter a signature below, check this box” checkbox and types in Applicant Name.
  - Applicant Name is required
  - A notice appears notifying user of their acknowledgement of accepting terms and condition and that such actions will be taken as their digital signature.
  - Signature box will be disabled
- Witness use the digital signature and clicks accept
  - Witness name is required.
  - A digital signature will be attached to the application.
  - The checkbox and Witness Name field will be disabled. User will have to click clear to edit the signature and Witness Name and enable the checkbox option.

\*Same behavior applies when Applicant uses digital signature and Witness checks the checkbox
