This frame contains the agency name, physical address, telephone number, and point of contact as well as the corresponding email address. The 2024 CPFFCL frame will be compared against the current frames for the DEA National Forensic Laboratory Information System, BJS Census of State and Local Law Enforcement Agencies, and BJS Census of Federal Law Enforcement Officers to identify any new eligible agencies.
