<b>What is this collection about?</b>	This information collection requires States to submit to TSA an application for approval of a temporary waiver, under section 37.7, of the prohibition on Federal acceptance, for official purposes, of mobile driver's licenses (mDLs) that do not comply with the REAL ID Act and regulations.
