## **Pathways to Partnerships Project and Partner Staff Interview Guide**

Thank you for meeting with me today.   - a. Probe: What specific goals do you have for the partnerships?

- b. Probe: What is or is not working about these partnership activities?
- c. Probe: Are your partners contributing as planned?

Let's talk about the training or professional development your project is offering to youth service professionals.

- 10. What kinds of training or professional development is the project offering to youth service professionals?
