Instructions for Video File Submission (Maximum of two minutes in length):

We are excited for the opportunity to hear from you in a brief introduction video. Tell us a little more about yourself in your own words. This is your chance to speak directly to the panelists who will review your application. Videos should be no longer than 2 minutes in length. Please do not

worry about this video looking “professional.” We encourage you to record it at home on your phone or computer (so long as we can clearly hear and see you.) Alternatively, you may submit this information in a one-page PDF.

Here are some sample question prompts you can include in your video (or written statement):

Poetry Out Loud only:

- How has participating in Poetry Out Loud changed your relationship with poetry?
- What is something that you learned about yourself—or in general—from participating in Poetry Out Loud?
