Motor Gasoline Price Survey Form EIA-878 Schedule B

YOUR RESPONSE IS REQUIRED BY LAW

This report is **mandatory** under the Federal Energy Administration Act of 1974 (Public Law 93-275). Failure to comply may result in criminal fines, civil penalties, and other sanctions as provided by law. **Title 18 USC 1001 makes it a criminal offense for any person knowingly and willingly to make to any Agency or Department of the United States any false, fictitious, or fraudulent statements as to any matter within its jurisdiction.**

Form EIA-878 shall be submitted by all scientifically sampled retail motor gasoline outlets. Companies sampled are notified in writing and by telephone in advance.

PURPOSE

The U.S. Energy Information Administration (EIA) Form EIA-878, Motor Gasoline Price Survey is a mandatory survey consisting of two parts: Schedules A and B. Schedule A is designed to collect data on the cash, pump price (including taxes) of self-serve, unleaded gasoline, by grade of gasoline. Schedule B is designed to collect total annual sales volume for each grade of gasoline sold at your station during a full calendar year. Schedule B is conducted **only once** when your station was selected in a new sample for the survey, and the data are collected strictly for internal statistical purposes and will not be published.

The data collected on Schedule A are used to calculate average gasoline prices at the national, regional, and select state and city levels across all gasoline grades and formulations. These data are point-in-time estimates as of 8:00 a.m. Monday.

PROVISIONS REGARDING CONFIDENTIALITY OF INFORMATION

The information you provide on Form EIA-878 will be used for statistical purposes only and is confidential by law. In accordance with the Confidential Information Protection and Statistical Efficiency Act of 2018 and other applicable Federal laws, your responses will not be disclosed in identifiable form without your consent. Per the Federal Cybersecurity Enhancement Act of 2015, Federal information systems are protected from malicious activities through cybersecurity screening of transmitted data. Every EIA employee, as well as every agent, is subject to a jail term, a fine, or both if he or she makes public ANY identifiable information you reported.

REPORTING AND ESTIMATED REPORTING BURDEN

Respondents are not required to file or reply to any Federal collection of information unless it has a valid OMB control number. SANCTIONS

The timely response of Form EIA-878 Schedule B by those required to report is **mandatory** under 15 USC 772(b), as amended. **Failure to respond may result in a civil penalty of not more than \$12,937 per day for each violation.** The government may bring a civil action to prohibit reporting violations which may result in a temporary restraining order or a preliminary or permanent injunction without bond. In such civil action, the court may also issue mandatory injunctions commanding any person to comply with these reporting requirements.
