#### Waiver of Launch Collective Risk Limit for a Near-Orbital Trajectory

**AGENCY:** Federal Aviation Administration (FAA), Department of Transportation. **ACTION:** Notice of waiver.

SUMMARY: This notice concerns a petition for waiver submitted to the Federal Aviation Administration (FAA) by Space Exploration Technologies Corporation (SpaceX) to waive the launch collective risk limit of  $1 \times 10^{-4}$ expected casualties (E<sub>c</sub>) for Starship Super Heavy missions that utilize a near-orbital trajectory. The near-orbital Starship Super Heavy missions have been deemed suborbital such that a single launch collective risk limit of 1  $\times 10^{-4}$  E<sub>c</sub> has been applied to cover the aggregate of the risks from the suborbital launch and suborbital reentry phases of each mission. The SpaceX petition requests an increase to the collective risk limit, to not exceed  $2 \times 10^{-4}$  E<sub>c</sub>, with the condition that neither the suborbital launch nor suborbital reentry risks exceed  $1 \times 10^{-4}$  E<sub>c</sub> individually. The FAA grants the petition for nearorbital Starship Super Heavy missions to allow a risk budget that parallels but remains consistent with an orbital mission profile that has a separate risk limit of  $1 \times 10^{-4}$  E<sub>c</sub> for both the launch and reentry phases.
