Abstract: The FFDO Program enables TSA to screen, select, train, deputize, and supervise qualified pilots, flight engineers, and navigators who voluntarily agree to defend the flight decks of commercial passenger and all-cargo airliners against acts of criminal violence or air piracy. Information collected as the result of this proposal is used to assess the eligibility and suitability of prospective and current FFDOs, to ensure the readiness of every FFDO, to administer the program, and for security purposes. The program also includes the requirement for FFDOs to report prescribed incidents to TSA.

These reportable incidents include, but are not limited to, the discharge or drawing of a weapon, any attacks or attempted attacks on the flight deck, and the loss or damage of any weapon/ammunition. TSA is revising the collection by discontinuing the TSA verbal interview and enabling online submission of answers to certification questions.
