Abstract: The Animal Health Protection Act (7 U.S.C. 8301 et seq.) provides the Secretary of Agriculture broad authority to prohibit or restrict, through orders and regulations, the importation or entry of any animal, article, or means of conveyance if the U.S. Department of Agriculture determines that the prohibition or restriction is necessary to prevent the introduction or spread of any pest or disease of livestock within the United States. Disease prevention is the most effective method for maintaining a healthy animal population.

As an element of the Animal and Plant Health Inspection Service (APHIS) disease prevention mission, the National Veterinary Services Laboratories (NVSL) safeguard U.S. animal health by ensuring that timely and accurate laboratory support is provided through a nationwide animal

health diagnostic system. NVSL's work necessitates the use of several information collection activities including requests for reagents or supplies, NVSL contact information updates, NVSL applications for laboratory training, and the ability to order NVSL laboratory kits and instruments.

We are asking the Office of Management and Budget (OMB) to approve our use of these information collection activities, as described, for an additional 3 years.

The purpose of this notice is to solicit comments from the public (as well as affected agencies) concerning our information collection. These comments will help us:

- (1) Evaluate whether the collection of information is necessary for the proper performance of the functions of the Agency, including whether the information will have practical utility;
- (2) Evaluate the accuracy of our estimate of the burden of the collection of information, including the validity of the methodology and assumptions used;
- (3) Enhance the quality, utility, and clarity of the information to be collected; and
- (4) Minimize the burden of the collection of information on those who are to respond, through use, as appropriate, of automated, electronic, mechanical, and other collection technologies; *e.g.*, permitting electronic submission of responses.

Estimate of burden: The public burden for this collection of information is estimated to average 0.25 hours per response.

Respondents: Domestic and foreign diagnostic laboratories (Federal, State, university, or private), researchers (academia, private, government), and private veterinary practitioners.

Estimated annual number of respondents: 970.

Estimated annual number of responses per respondent: 4.

Estimated annual number of responses: 4,079.

Abstract: In accordance with the Paperwork Reduction Act of 1995 (Pub. L. 104–13) and OMB regulations at 5 CFR part 1320 (60 FR 44978, August 29, 1995), this notice announces the ERS intention to request renewal of approval for an annual information collection. The U.S. Census Bureau supplements the December CPS with questions regarding household food shopping, use of food and nutrition assistance programs, food sufficiency, and difficulties in meeting household food needs.

ERS is one of the 13 principal statistical agencies of the federal government and is responsible for conducting studies and producing statistics on food security in U.S. households. The data collected by the

food security supplement will be used to monitor the prevalence of food security and the prevalence and severity of food insecurity among the Nation's households. The prevalence of these conditions as well as year-to-year trends in their prevalence will be estimated at the national level and for population subgroups. The data will also be used to monitor the amounts that households spend for food and their use of community food pantries and other community food assistance. These statistics along with research based on the data will be used to identify the causes and consequences of food insecurity, and to assess the need for, and performance of, domestic food and nutrition assistance programs. The data will also be used to improve the measurement of food security and to develop measures of additional aspects and dimensions of food security. This consistent measurement of the extent and severity of food insecurity will aid in policy decision-making.

The supplemental survey instrument was developed in conjunction with food security experts nationwide as well as survey method experts within the Census Bureau and was reviewed in 2006 by the Committee on National Statistics of the National Research Council.

Authority: Legislative authority for the planned data collection are 7 U.S.C. 2204(a) and 7 CFR 2.67. These statutes and regulations authorize the Secretary of Agriculture and the Administrator of the Economic Research Service to conduct research and collect statistics on the U.S. food system, consumers, and human nutrition.

Confidentiality: The Census Bureau

collects data for the Current Population Survey under the authority of Title 13, U.S. Code, section 8b, which allows the Census Bureau to undertake surveys for other government agencies. Under Title 13, U.S. Code, section 9 the Census Bureau holds all information in strict confidence. Information reported in the survey which would permit the identification of a household or any of its members is not reported to anyone outside of the Census Bureau. Any Census Bureau employee who violates these provisions is subject to a fine of up to \$250,000, a Federal prison sentence of up to five years, or both.

Estimate of Burden: Public reporting burden for this collection of information is estimated to average 7.1 minutes per response.

Respondents: Households. Estimated Number of Annual Respondents: 51,937.

Éstimated Total Annual Burden on Respondents: 6,108 hours.

Abstract: Section 18 of the Richard B. Russell National School Lunch Act authorized and funded USDA to establish a farm to school program in order to assist eligible entities, through grants and technical assistance, in implementing farm to school programs that improve food and agriculture education as well as access to local foods in schools. This work is housed within the FNS Community Food Systems Division. As part of the Farm to School Program's authorization, CFSD collects and disseminates information on farm to school activity throughout the country. CFSD conducted a national census of farm to school activity in 2013, 2015, 2019, and 2023. The Farm to School Census provides the only nationallyrepresentative data available on farm to school participation and activities in the United States.

The 2027 Farm to School Census (Census) will collect and synthesize data from a national census of SFAs to better understand the characteristics of SFAs participating in farm to school and the scope and details of the activities
