What is the 2024-25 School Pulse Panel?

The 2024-25 School Pulse Panel (SPP) is a monthly data collection designed to measure a rotating collection of high-priority, education-related topics. These topics are developed in collaboration with program offices within the U.S. Department of Education and across the federal government and represent their school-based data needs. This collaboration reduces the number of federal surveys that your school is asked to participate in.

How is the 2024-25 School Pulse Panel different from other education surveys?

Unlike other federal data collections that are conducted once every few years and release data a year or more after the formal end of data collection, the School Pulse Panel surveys a small sample of schools every month and releases those estimates to the public approximately six weeks after the end of each data collection. These near real-time data are regularly used by senior staff within the Department of Education, the White House Domestic Policy Council, and Congress to inform policies, budgeting decisions, and grant opportunities.

Why should my school participate?
