

## Agency for Healthcare Research and Quality TeamSTEPPS® for Long-Term Care – Focus Group Screener

### **Background information**

Candidates will be screened to ensure that participants fall into the necessary range of professional roles within the long-term care field. Questions about gender, age, race and ethnicity, and professional and academic backgrounds are included in the screener to achieve representation across diverse groups when possible.

Candidates selected to participate in the focus group study will receive an honorarium of either \$80, \$120, or \$250 based on their professional role.
