<b>Who must comply?</b>	Vessel and facility owners and operators operating in the U.S. Maritime Transportation System that are regulated by 33 CFR parts 101, 104, 105, and 106.
<b>What is this collection about?</b>	The Coast Guard (CG) implemented cybersecurity regulations in Title 33 CFR Part 101. A prime element of these requirements is security assessments and plans for MTSA-regulated vessels, facilities, and Outer Continental Shelf (OCS) facilities. These security plans involve collections of information that are vital to securing the safety of maritime areas. These requirements are critical in determining appropriate security measures to reduce the risk of a Transportation Security Incident (TSI).
<b>Where do I find the requirements for this information?</b>	Title 33 CFR, is available at— <a href="https://www.eCFR.gov">https://www.eCFR.gov</a> , select TITLE 33 – NAVIGATION AND NAVIGABLE WATERS, and follow to subchapter H – Maritime Security.
<b>When must information be submitted to the Coast Guard?</b>	Security plans and related material must be submitted— <ul style="list-style-type: none"> <li>• For a new vessel or facility, prior to operation, or</li> <li>• For an existing vessel or facility with an approved CG security plan, prior to the expiration of the plan or when changes/updates are required or deemed necessary.</li> </ul>
<b>How is the information submitted?</b>	By mail, fax or electronically submitted via e-mail to the CG. <b>What happens when complete information is received?</b>	The CG will review the information and respond via writing.
