It is conducted by the National Science Foundation (NSF), an independent agency of the U.S. government that supports research and education. The U.S. Census Bureau serves as the data collection contractor for the NSCG on behalf of NSF.

### How is the information used?

- Study the relationship between education and career opportunities in the United States,
- Assist people in making education and career choices,
- Inform decisions about how to best use limited resources in the areas of research, education, and job training

### Who should participate?
