TITLE OF INFORMATION COLLECTION: U.S. Securities and Exchange Commission
Registration& Feedback Questions

PURPOSE: The U.S. Securities and Exchange Commission (SEC)’s Office of the Advocate for Small Business Capital Formation (Office) is seeking to collect responses and feedback from individuals who register for, and attendees of, an event (Event). The Event will be organized by the Office and hosted by the SEC and is scheduled for April 10, 2025 (although registration is expected to begin as early as March 1, 2025).
