5	Stockyard Owned or Leased	Check the appropriate box
6	Names of Owners or Lessees'	Enter the name(s) of owners or officers, including individuals and partners or members. Attach a separate page if necessary.
7	Mailing Address of Stockyard	Enter the number, street, city, state, and zip +4 of the mailing address of the stockyard.

8	Change Date	Enter the date of the change of name.
9	Signature	An owner, officer, or member of the stockyard must sign the form. Electronic signatures are considered valid.
10	Print Name	Print the name of person signing the form.
11	Title	Enter the title of the owner, officer, or member who signed the form.
12	Date	Enter the date the form was signed.
