Use Form PSD 1200 to provide information to the Packers and Stockyards Division (PSD) about a facility used as a market for selling livestock in commerce. The Secretary of Agriculture will use this information to determine whether the facility meets the definition of a stockyard in Section 302 of the Packers and Stockyards Act, 1921, as amended and supplemented (7 U.S.C. 202) and, therefore, is required to be posted.
