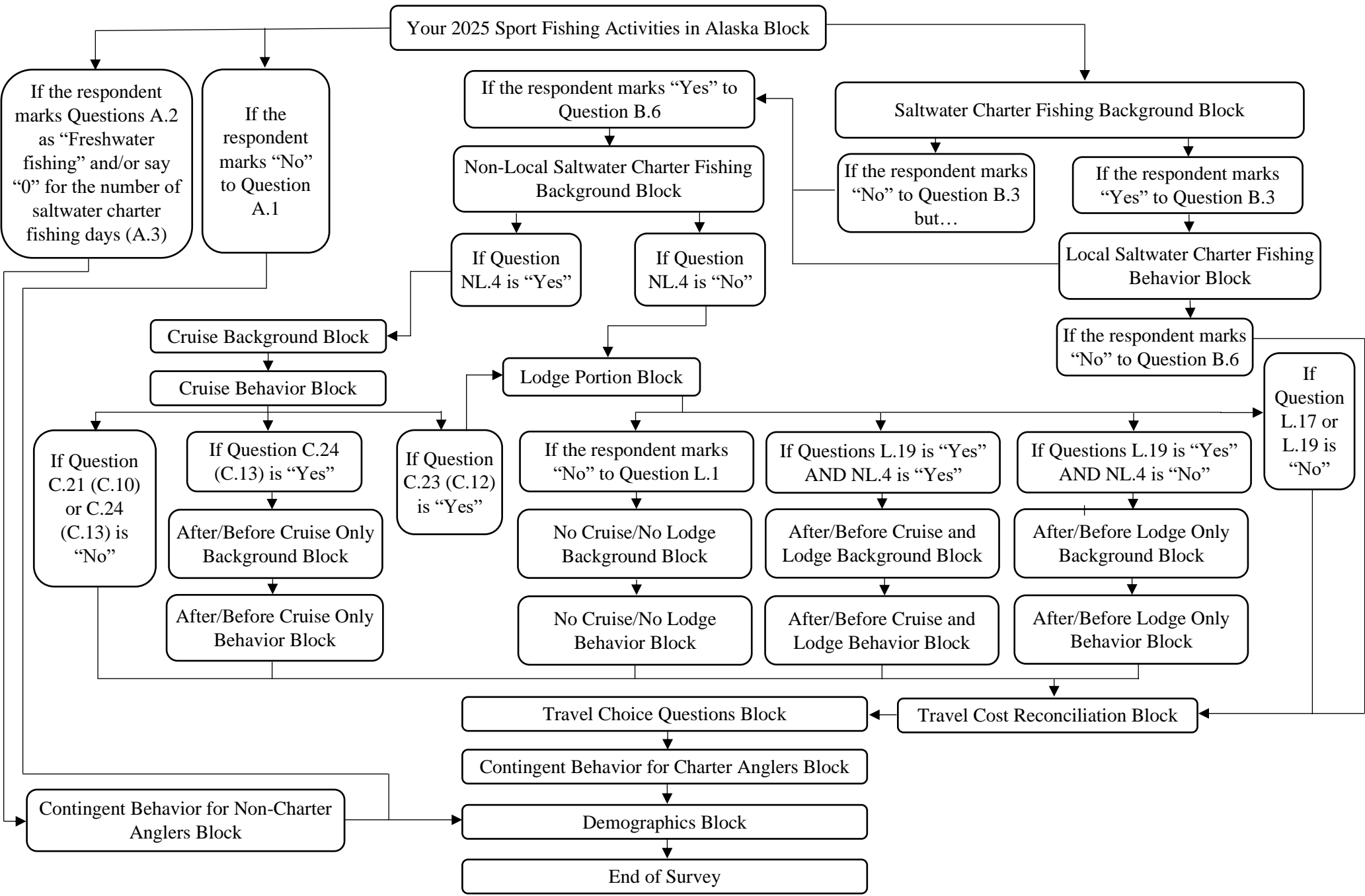







# Survey Flow Diagram

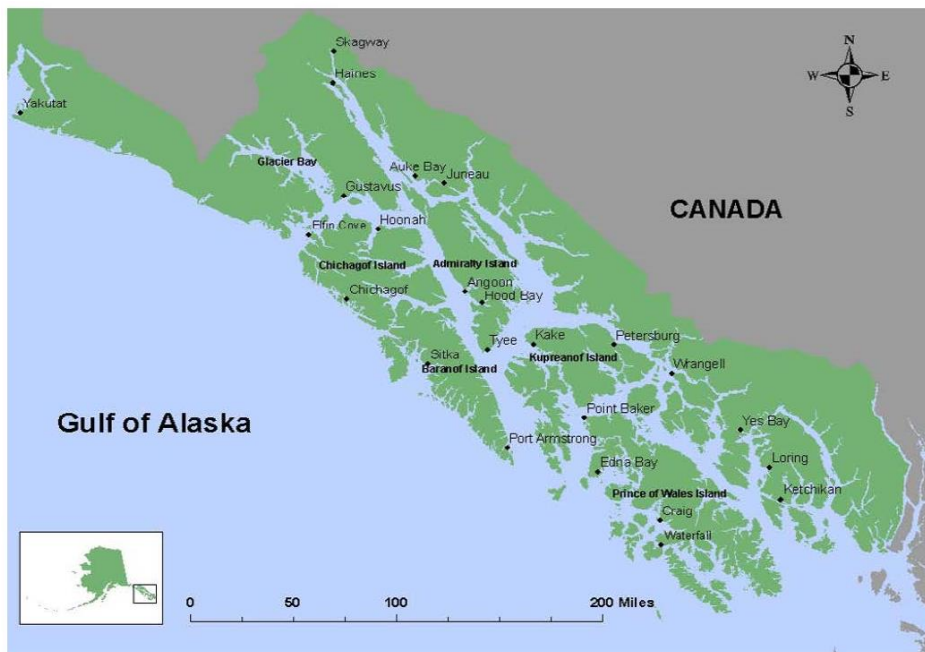

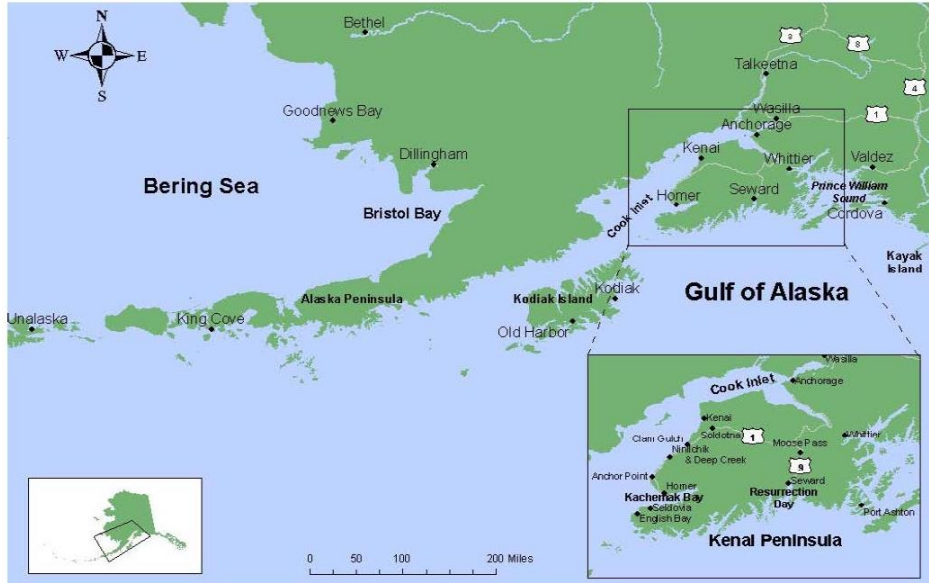


**Map A: Southeast Alaska**

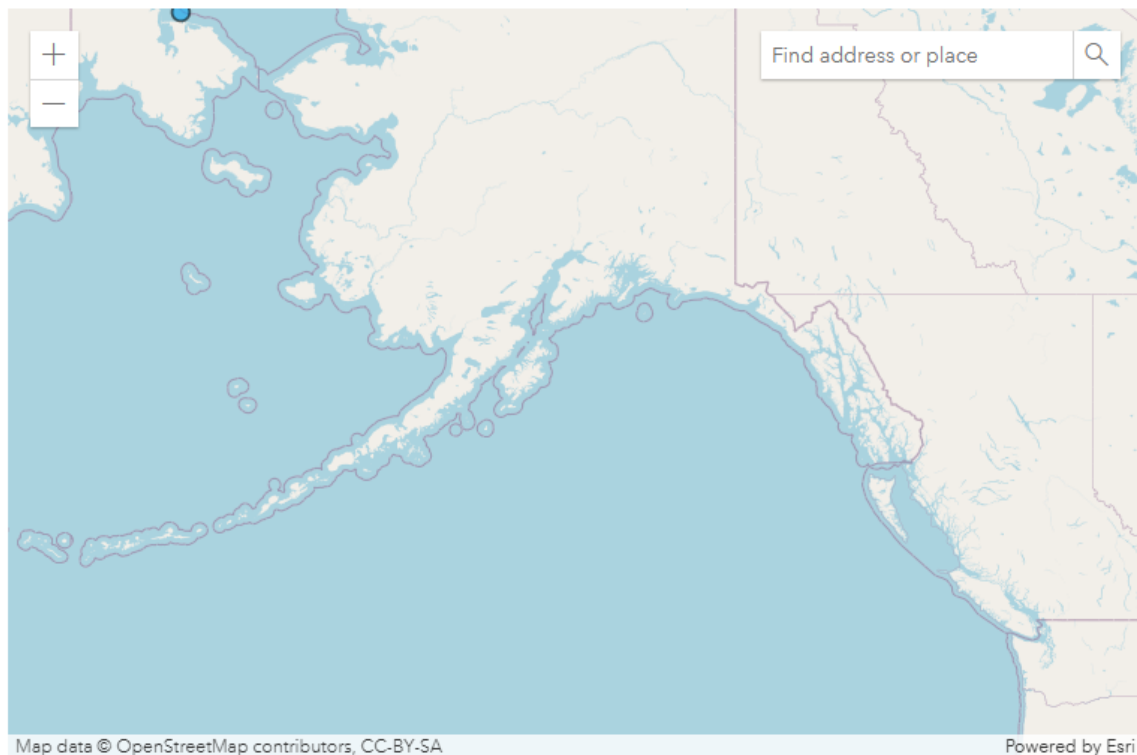

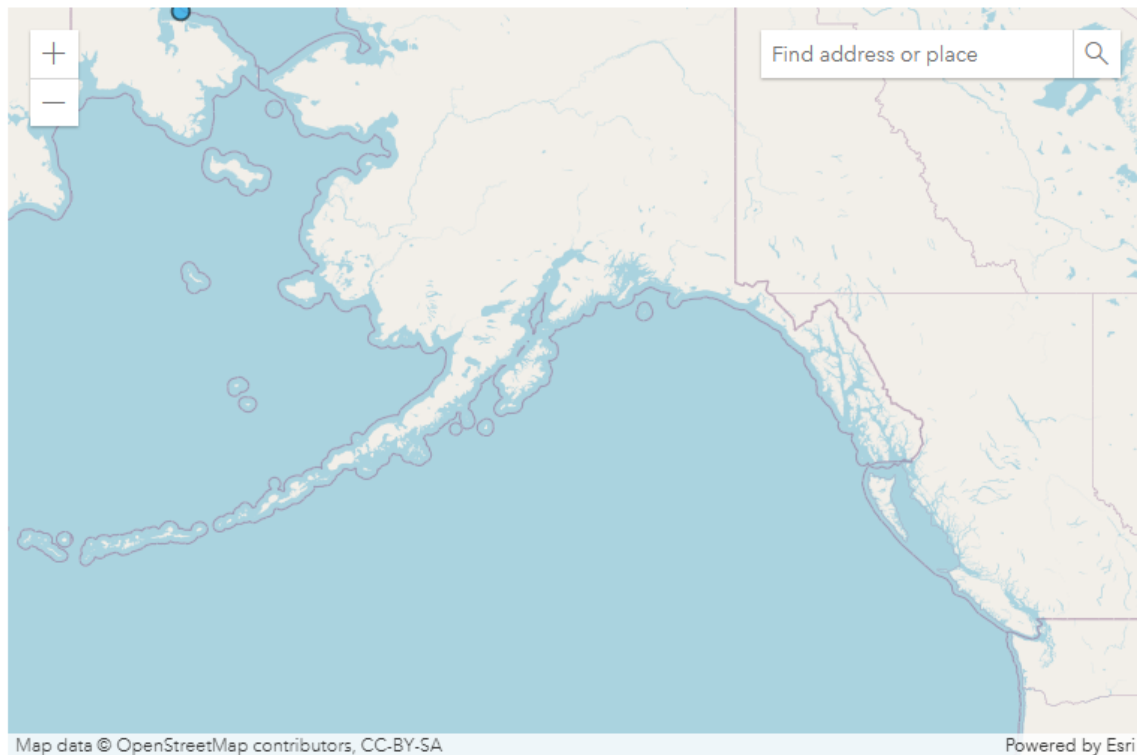

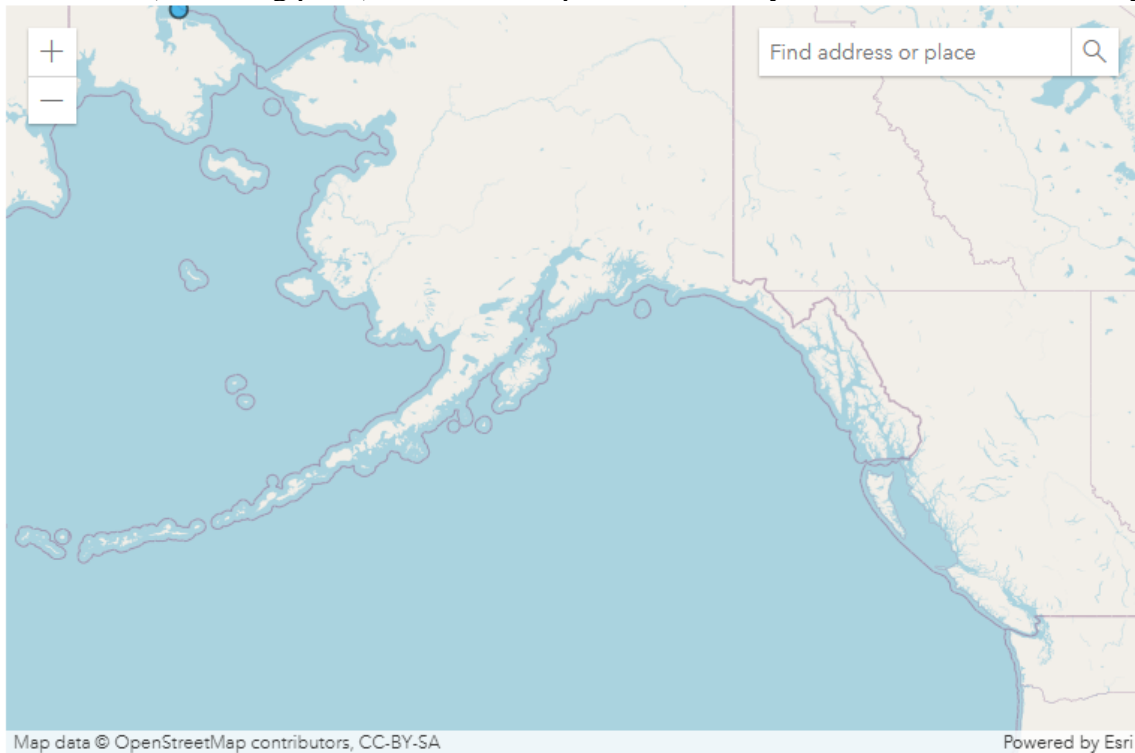

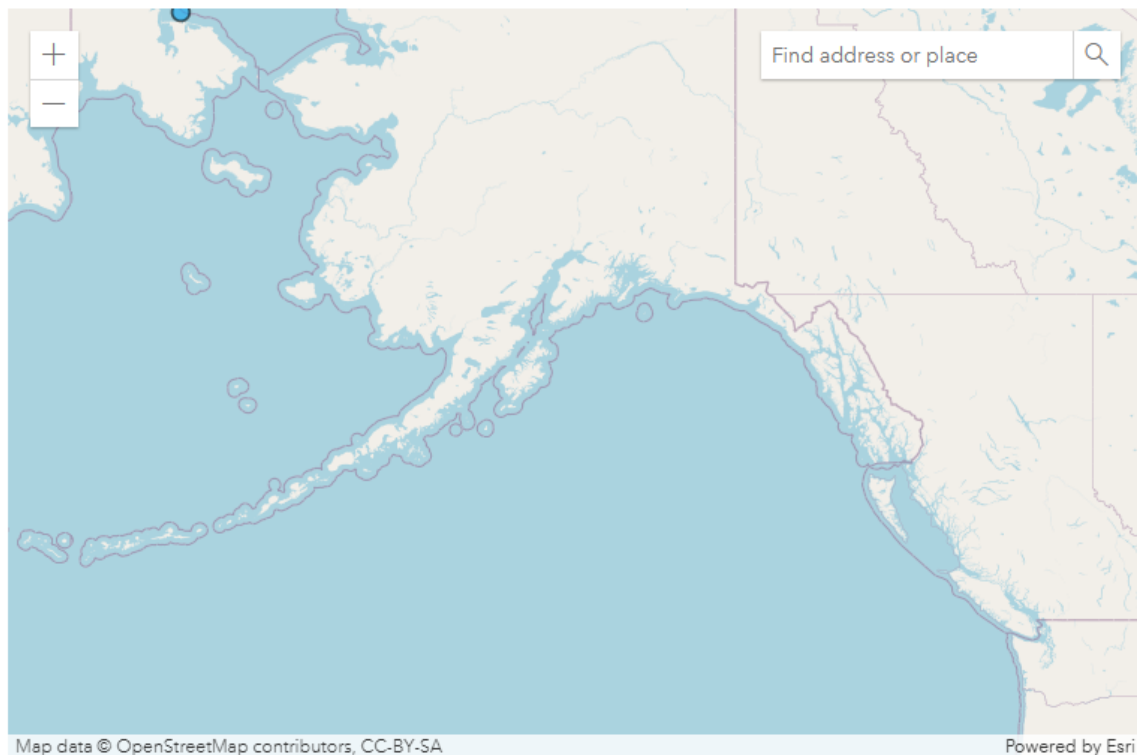

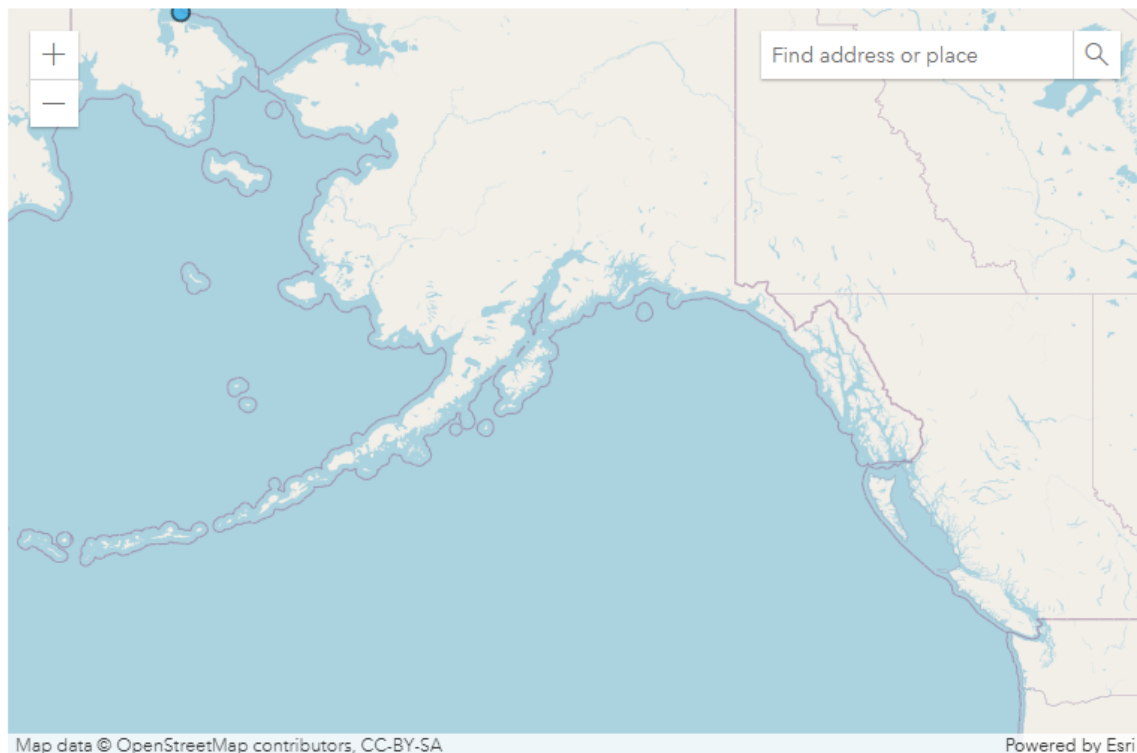
