## **2024 Reinterview**

### **Procedure for finding respondent for Redesigned Reinterview:**

If there's a Sample Adult interview then we will attempt to contact the Sample Adult for Reinterview. If there's no Sample Adult interview, but there is a Sample Child interview then we will attempt to contact the Sample Child Proxy for Reinterview. If there is no Sample Child interview, then we will attempt to contact the Household Respondent.

In the rare case that the Sample Adult interview was completed by a proxy, we will not attempt to contact the Sample Adult or Sample Adult proxy for the reinterview. We will move to trying to contact the Sample Child Proxy (therefore sample adult questions will be skipped), and if there is no Sample Child proxy, then we will attempt to contact the Household Respondent.

The content verification questions are specific to the respondent who answered the original question (either Sample Adult or Sample Child proxy). These questions are only asked when there was a response from the related question in the original interview. Respondents will not be reinterviewed on topics they weren't asked about originally. All responses are dichotomous "Yes" or "No"

### **START OF REINTERVIEW QUESTIONNAIRE**

*Read to respondent - Now I am going to ask you a few questions to verify that the survey was administered correctly. Each person can be asked different questions, so please answer questions according to your memory.*

*Note: only read if there is a Sample Adult or Sample Child proxy to administer the following questions to:*

#### **Adult Annual Content**

Q1. Did the interviewer ask whether you were covered by health insurance or some other kind of health care plan? (**SAHINS**)

Universe: Sample adults 18+ (If HICOV\_A has a valid response, 1,2, rf,dk)

Q2. Did the interviewer ask you about the amount of your total family income? (**SAINC, note: previously called FAM3**)

Universe: Sample adults 18+ or Sample children < 18 (If INCWRKO\_A has a valid response 1,2,rf,dk OR INCWRKO\_C has a valid response 1,2,rf,dk)

*Note: If the total family income question was asked as part of the Sample Adult interview, then ask this question of the Sample Adult in reinterview. Else, if the total family income question was asked as part of the Sample Child interview, then ask this question of the Sample Child respondent in reinterview.*

Q3. Did the interviewer ask whether your house has a functioning smoke detector? (**SMKDET**)

Universe: Sample adults 18+ or proxy for Sample Child (NOTE: This is a control item; we do not ask about smoke detectors)

Q4. Did the interviewer ask you whether there is a place that you usually go to when you are sick or need health care? (**SAAUSUAL**)

Universe: Sample adults 18+ (If USUALPL\_A has a valid response 1,2,3,rf,dk)

Q5. Did the interviewer ask whether you consider yourself to be {if '1' to SEX\_FINAL: gay, straight, bisexual, or something else/if '2', 'RF', 'DK' to SEX\_FINAL: lesbian or gay, straight, bisexual, or something else}? (**S<sub>A</sub>ORIENT**)

Universe: Sample adults 18+ (If ORIENT\_A has a valid response 1,2,3,4,5,rf)

Q6. Did the interviewer ask for the last four digits of your social security number? (**S<sub>A</sub>SOC**)

Universe: Sample adults 18+ (If SSN4\_A has a valid response string, N (doesn't have SSN), rf,dk)

### **2024 Sponsored Adult Content:**

Q7. Did the interviewer ask if you had difficulty with your sense of smell or ability to detect odors? (**S<sub>A</sub>SMELL**)

Universe: Sample adults 18+ (If SMELLDF\_A has a valid response 1,2,3,4,5,rf,dk)

Q8. Did the interviewer ask you if you had a sunburn on your skin in the past 12 months? (**S<sub>A</sub>SUNBURN**)

Universe: Sample adults 18+ (if ANYSBURN1\_A has a valid response 1,2,rf,dk)

### **2024 Rotating Adult Core Content:**

Q9. Did the interviewer ask if you had any accident or injury where any part of your body was hurt in the past 3 months? (**R<sub>C</sub>INJURY**)

Universe: Sample adults 18+ (if ANYINJURY\_A has a valid response 1,2,rf,dk)

*Read to respondent –Thank you. These next two questions are to make sure that the interviewer recorded the correct responses in the original interview:*

*Note: Should this only be read if PREDIB\_A or SMKEV\_A were not empty.*

### **Adult Annual Content**

Q10. Has a doctor or other health professional EVER told you that you had prediabetes or borderline diabetes? (**S<sub>A</sub>PREDIB**)

Universe: Sample adults 18+

Note: We are now going to open this question up to all sample adults with a valid response to assess response variance. Therefore ask if there is a valid response to PREDIB\_A (1,2,rf,dk).

Q11. Have you smoked at least 100 cigarettes in your ENTIRE LIFE? (**S<sub>A</sub>SMKEV**)

Universe: Sample adults 18+

Note: We are now going to open this question up to all sample adults with a valid response to assess response variance. Therefore ask if there is a valid response to SMKEV\_A (1,2,rf,dk).

*Read to respondent –[Fill: Now] I am going to ask about two questions you were asked to answer on behalf of the following child in your family: ^SCNAME.*

*Note: This should only be read if the Sample Adult is also the Sample Child respondent.*

### **Child Annual Content**

*Note: This should only be read if the reinterview respondent was Sample Child Respondent (RIRESP = LNO\_SCRESP or Sample Adult received question first SARESPSC\_FLG=1).*

Q12. Did the interviewer ask you if ^SCNAME was ever diagnosed with asthma? (**S<sub>C</sub>ASTHMA**)

Universe: (If ASEV\_C has a valid response 1,2,rf,dk)

Q13. Did the interviewer ask you if ^SCNAME had a flu shot in the past 12 months ? (**SCFLUSHOT**)

Universe: Sample children 0-17 and (If SHTFLU12M\_C has a valid response 1,2,rf,dk)

**2024 Child Rotating Content:**

*Note: This should only be read if the reinterview respondent was Sample Child Respondent (RIRESP = LNO\_SCRESP).*

Q14. Did the interviewer ask you if ^SCNAME had an allergy to one or more foods? (**SCFOODALG**)

Universe: Sample children 0-17 and (If CURFOOD\_C has a valid response 1,2,rf,dk)

**2024 Child SponsoredContent:**

*Note: This should only be read if the reinterview respondent was Sample Child Respondent (RIRESP = LNO\_SCRESP).*

Q15. Did the interviewer ask you if ^SCNAME lost consciousness or been dazed due to a blow or jolt to the head in the past 12 months? (**TBILCDAZE**)

Universe: Sample children 0-17 and (If TBILCDCMG\_C has a valid response 1,2,rf,dk)
