## 1. <u>Need for the Information Collection</u>

The Department of Veterans Affairs (VA) through its Veterans Benefits Administration (VBA), administers an integrated program of benefits and services, established by law, for veterans, service personnel and their survivors. Information is requested by VA Form 21-686c, *Application Request to Add and/or Remove Dependents*, under the authority of 38 U.S.C. § 1115, provide that an additional allowance for dependents may be payable to certain veterans and surviving spouses who are entitled to compensation and/or pension benefits. Regulatory authority is found in 38 C.F.R. § 3.205 and 3.209.

## 2. <u>Use of the Information</u>

The respondent population for VA Form 21-686c is composed of individuals who may be entitled for an additional allowance for dependents or to remove dependents already established.

As such, this collection of information is used to obtain current information about marital status and dependent child(ren). The information is needed to determine the correct rate of payment for veterans and beneficiaries who may be entitled to an additional allowance for dependents or to remove dependents.

## 3. Use of Information Technology

VA Form 21-686c is available on the One-VA Website in a fillable electronic format. VBA is currently hosting this form on a secure server and does not currently have the technology in place to allow for the complete submission of the form. Validation edits are performed to assure data integrity. The collection of information does involve the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology.

The information obtained through this collection is unique and is not already available for use or adaptation from another cleared source.

#### 12. Respondent Burden and its Labor Costs

- a. Total number of Respondents is estimated at **<u>535,538</u>** per year.
  - i. Online portal respondent estimate: 342,075.
  - ii. Intake center respondent estimate: 193,463.
- b. Frequency of Response is one time.
- c. Annual burden hours are 267,769 hours.
- d. The estimated completion time for this form is 30 minutes.
- e.VA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA uses general wage data to estimate the respondents' costs associated with completing the information collection.

The Bureau of Labor Statistics (BLS) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean hourly wage is \$32.66 based on the BLS wage code – "00-0000 All Occupations." Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection.
