



## NASA Grants, AO and NRA Submission System User Feedback

NASA's Science Mission Directorate (SMD) is soliciting participant feedback on their experiences with submitting proposal or participating in proposal reviews for NASA Grants, Cooperative Agreements and Announcement Opportunities (AO) through the NASA Solicitation and Proposal Integrated Review and Evaluation System (NSPIRES).

The anonymous form is designed to collect information on your experiences finding funding opportunities, submitting proposals, notification of your proposal status, and panel proposal review participation. Your feedback will help SMD identify IT system enhancements to improve your experience.
