No approval may be given to hazelnut handlers wishing to transfer excess restricted credits unless a completed request form is received and approved by the Board. (7 U.S.C. 608(d), 7 CFR 982.53 and 7 CFR 982.460).

According to the Paperwork Reduction Act of 1995, an agency may not conduct or sponsor, and a person is not required to respond to a collection of information unless it displays a valid OMB control number.
